Comment: The flow back operations being performed at the location are a green complete style. This kind of flow back consists of a Primary or high stage. This vessel does most of the work in the flow back operation, separating the oil, gas and water. Gas is sent to sales. The water is then shipped to a secondary vessel, or low stage, where the final breakout of gas occurs. The gas is then flared off via the portable combustor. The water is then shipped to the flow back tanks and reused for the Frac operations after being chemically treated. The location also has a system in place that pulls a vacuum from the 6 flow back tanks and adds an odor control scent before being released to atmosphere.
