742.27 Acres



(5). Copies of the required notification letters are on file at SRC Energy's office. The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. We have not received any objections to such well location or proposed spacing unit, therefore, SRC Energy hereby requests the Director approve the well.

BOST FARM 26N-8B-L WELLBORE SPACING UNIT




BOST FARM 26N-8B-L WELL TO BE LOCATED 1297' FNL AND 942' FWL, SEC 7, T5N, R66W
