The nearest wellbore completed or permitted in the same formation is Bison's proposed Jamaso 4-65 5-6-11, approximately 400' away. The nearest wellbore completed or permitted by another operator is the Property Reserve 4-65 3-4 1H, approximately 783' away. The attached anti-collision report, labeled "other" was used to determine both distances.

Distances measured between the proposed wellbores and other proposed wellbores on the same Jamaso pad were reported on the offset well evaluation per the anti-collision report.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
