Comment:

Previous inspection required operator to perform additional reclamation activities on the location, and to perform reclamation on the access road. Inspector found evidence that reseeding occurred on location. Operator appears to have conducted work on part of the access road, however, it does not appear as though compaction alleviation was conducted in accordance to 1004.a; the access road appears to have only been ripped once (rather than a cross-ripping) in the ruts of the access road, with one pass-through. Compaction concerns remain. In addition, there is ~1200 feet of access road to the north where operator has failed to recontour/re-grade, de-compact and reclaim. See attached photos. Original corrective action/date remains applicable.

Corrective Action:

Perform reclamation in accordance to COGCC 1000 series rules on the access road, including by not limited to, removing gravel, compaction alleviation, regrading/recontouring and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 3/31/2018.
