The well pad and access road were recontoured to match the surrounding terrain. This process allowed for soil decompaction. The topsoil stockpile was used during reclamation activities. Grading techniques were installed on the contour to promote ground infiltration and prepare the soil for seeding. The earth disturbance was stabilized by hydro-seeding with an approved Hill Ranch seed mix to promote the establishment of vegetation. A dirt berm was installed at the toe of reclamation for sediment control on the pad. All piping and debris were removed from location.

The earth disturbance was stabilized by hydro-seeding with a mulch tackifier and an approved Hill Ranch seed mix to promote the establishment of vegetation. A dirt berm was installed at the toe of reclamation for sediment control on the pad. All of the reclaimed areas are designed to sheet flow.
