COMMENTS:

The purpose of this sundry is to notify the COGCC of its intent to utilize the MLVTs located/approved on this location for the frac of the Geib Location ID 450654. PDC will not require any additional MLVT tanks or disturbance area than was approved on the original permit. The anticipated time the remote location will be receiving water from the MLVTs is approximately 1 month. Water will be transferred from the MLVT to the Geib remote location via temporary above ground water pipeline (a.k.a. layflat hose). The temporary water pipeline will cross County Road 47. PDC plans to bore under an asphalt/paved road and will install an open cut culvert to a dirt/gravel county road, after obtaining approval from the Local Government. No surface water features will be crossed. There are no building units within 1000' of the MLVTs.

5	Storm Water/Erosion Control	This Stormwater Management Plan contains required elements associated with PDC's construction activities, as defined in the CDPS General Permit for Stormwater Discharges Associated with Construction Activity, Authorization to Discharge Under the Colorado Discharge Permit System (Permit No. COR-030000, re-issued and effective July 1, 2007).BMPs for sediment and erosion control will be accomplished through a combination of construction techniques, vegetation and re-vegetation, administrative controls, and structural features.
5	Construction	The MLVT area will be graded in preparation for construction of the MLVTs. The topsoil will be segregated, stockpiled, and protected from degradation due to contamination, compaction, and, to the extent practicable, from wind and erosion so that subsequent reclamation of the MLVT area will be facilitated. If the MLVTs will be tore down in between frac, the underlying soil will be ripped and disked to control dust, minimize erosion and maintain site stabilization between MLVT setups.
5	Construction	PDC will conduct daily, visual inspections of the exterior wall and general area for any integrity deficiencies before, during, and after filling the MLVTs. PDC uses Construction Sign-Off, Site Preparation Sign-Off, Completion Sign-Off, Pre-Fill, and Site Visit checklists to maintain a written record of inspections. However, when the fluid level in the MLVTs is less than two (2) feet and there is no activity going on (i.e. break between completions), only intermittent inspections will be conducted. Two feet is the safe volume of fluid level that is needed to hold the liner down and keep the MLVT stable.
