Distance from the proposed wellbore to the nearest existing or proposed wellbore belonging to another operator, including plugged wells was measured to the Shut-In Kallsen 24-9 1 (API Number 05-001- 07732) operated by Extraction Oil and Gas. Confluence DJ LLC affirms it will not stimulate this planned wellbore within 150' of the Kallsen 24-9- 1's treated interval. Distance was measured in 2D using the COGCC map.
