Operator of the AL Well is seeking a Bond release which cannot be processed until responsibility / ownership of the AL Location is resolved; this Operator, Union Oil Company of California (ndba Chevron) has been instructed to Contact Laramie and discuss the issue. Aerial images are included in Photo log attached.

At present the Weed issue noted during inspection is being assigned to the Laramie Location and addressed in the Interim Reclamation Section.
