





Begin at the intersection of Mesa County Road 330E and Main Street in the Town of Collbran, Colorado. Travel easterly and northeasterly on County Road 330E 12.3 miles. Turn right onto Harrison Creek Road and travel southeasterly for 0.8 miles To a T intersection. Continue straight at the intersection and travel southeasterly along the Harrison Creek Road for 0.9 miles to a T intersection. Turn left and travel easterly for 0.4 miles to miles to a T intersection. Turn right and travel southeasterly for 1.5 miles to a T intersection. Turn right and travel less than 0.1 mile (~237 feet) to the staked access for the HAYWARD 0993-25-09 Pad. Turn right and travel northeasterly, for 0.1 miles (~521.2') to reach the proposed location.
