This subsequent report of abandonment is being submitted on behalf of the surface developer, Leyden Rock Development, Inc. The casing of the well was cut off during surface development.

A representative of the Leyden Rock Development, Inc. visually observed the well casings being lowered. The cut off elevation of 5,773 feet is estimated based on requirements to provide adequate clearance from proposed utilities and home foundations. This well was not surveyed.
