The tanks will be contained in a 44 ft. x 28 ft. lined containment ring and TEP is planning to abandon two 2-inch steel condensate pipelines from the PA 34-12 to the Doghead Production Facility. The lines will be abandoned in place per COGCC rules on Form 44. An updated facility diagram is attached.
