This Form 2 refile is being submitted to maintain the existing, open conductor pipe set for this well and future development plans. Well location updated to provide as-drilled location based on set conductor. Conductor information provided on the Casing tab is actual, as-drilled information. The Weinreis A pad is an existing pad containing 4 producing wells.. There is no additional surface disturbance associated with this refile, therefore a refilled / amended Form 2A is not required at this time. There have been no changes in land use or surface use agreement. Mineral lease information has been updated with this refile to correctly describe the BHL lease. Top of cement of 1st string/production casing will be >500 feet above top of gas.
