Operator Comment: This is a multi-use BLM road (Gibson Gulch Road) which is open to public use and is not considered either a lease or access road associated with our operations. All of our locations in this area are located on private surface behind the electric gate at the property line and every road leading to one of our locations from this

gate is considered a Vanguard lease or access road and is managed for stormwater compliance with COGCC and CDPHE regulations. I have discussed this with Darin Holtz and he has since discussed this CA with Shaun Kellerby. After a followup conversation with Darin today, Shaun has agreed with our assessment of this CA and Darin has directed Vanguard to proceed with this Factual Review Request to remove this CA from the inspection report.
