1	Noise mitigation	Nickel Road will install temporary sound walls on the south, east and west sides of the Oil and Gas Location to reduce noise and light impacts to the nearby residences. Please refer to attached sound study for recommendations. The sound walls will be installed prior to the commencing drilling and the walls will remain in place throughout the completions activities. Drilling rig and completion equipment engine exhaust will be directed away from occupied buildings.

Operator Comments:

NRO has completed a sound study for the Noble Pad. The sound study indicates that there is no sound wall needed on the northern side of the pad location as there are no proximate residences. Additionally, placing a sound wall on the northern side of the pad location may have the opposite desired effect by reflecting additional, unnecessary sound back towards the residences to the south. NRO requests that the noise BMP as originally submitted with the approved Form 2A be amended to reflect the sound study recommendations and remove the soundwall from the north side of the pad. Please see proposed, revised BMP language provided on the BMP tab of this sundry.

Additionally, please let this sundry serve as notice that NRO does not plan to utilize oil based muds on this pad as originally indicated on the approved Form 2A. NRO asks that this change be noted in the COGCC's system and the OBM (Odor) BMP be removed as it is no longer necessary.
