Operator Comment: Reclamation of the well pad and access road are complete. The top soil was utilized during reclamation activities. Grading techniques were installed on the contour. All disturbed soils were stabilized by hydro seeding with an approved Hill Ranch seed mix. The silt fence, stakes, location sign and top soil sign were removed from location.

The erosion issues were all corrected during the reclamation. (3) water bars were installed on the access road and (1) on the well pad. See attached photo log for details.
