Due to the lack of records from the previous operator, the reclamation start date is estimated to be approximately 3 months after the spud date. Once vegetative cover and weed control requirements are met, a Form 4 Sundry Notice will be submitted to COGCC documenting the completion of Interim Reclamation.
