Good Afternoon Ms. Hosuey,

I wanted to provide an update on comments submitted to the Colorado Oil and Gas Conservation Commission (COGCC) from East Cherry Creek Valley Water and Sanitation District (ECCV) dated January 24, 2018 regarding the Extraction Oil and Gas Duck Club Well Pad located in unincorporated Adams County Colorado 1S 66W Section 12

After receiving and reviewing the comments the COGCC provided to Extraction Oil and Gas (Extraction), Extraction set up a meeting with ECCV February 14, 2018 to discuss the aforementioned comments provided to COGCC. The meeting resulted in Extraction and ECCV agreeing that Extraction would provide the following deliverables to ECCV:

1. Provide the Tactical Response Plan (TRP [emergency response plan])
2. Provide an avenue for direct communication between ECCV and XOG
3. Provide a comprehensive list of Best Management Practices (BMPs) that will be implemented on the pad.
4. Install/fund the installation of two nesting monitoring wells as well as establish a testing and reporting protocol.

Extraction and ECCV also discussed a field tour of an Extraction well pad in production to show the BMPs in action as well as a possible tour of the ECCV facilities near the proposed Duck Club pad; however, these proposed field tours aren't exactly deliverables.

As of today's date May 9, 2018, extraction has provided to ECCV the following:

1. Extraction's Duck Club specific Tactical Response Plan (TRP)
2. Incorporated direct incident contact between Extraction and ECCV Water Treatment Plant Main office, Plant On-Call, and the Water Treatment Supervisor into the site specific TRP
3. Provided a comprehensive list of Best Management Practices for the Duck Club well pad

4. Agreed to install four 2-inch monitoring wells between the proposed well pad and ECCV well P-11, using a hollow-stem auger rig. Well installation will occur after drilling and completions but prior to interim reclamation

Extraction believes it has delivered the items requested by ECCV during its February 14, 2018 meeting and will continue to work with ECCV throughout the drilling completions and production phases of the Duck Club well pad.
