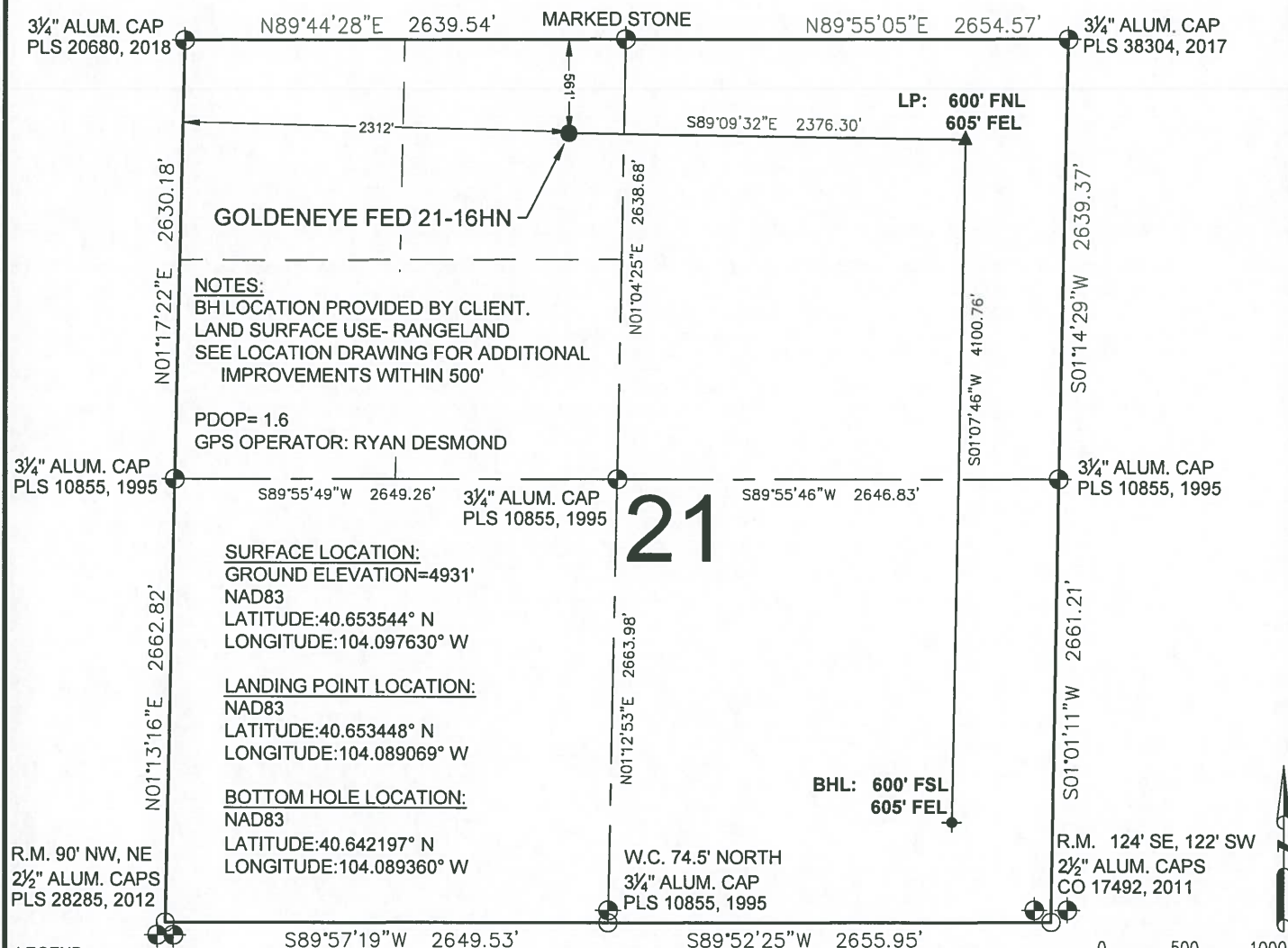


GOLDENEYE FED 21-16HN WELL LOCATION CERTIFICATE
