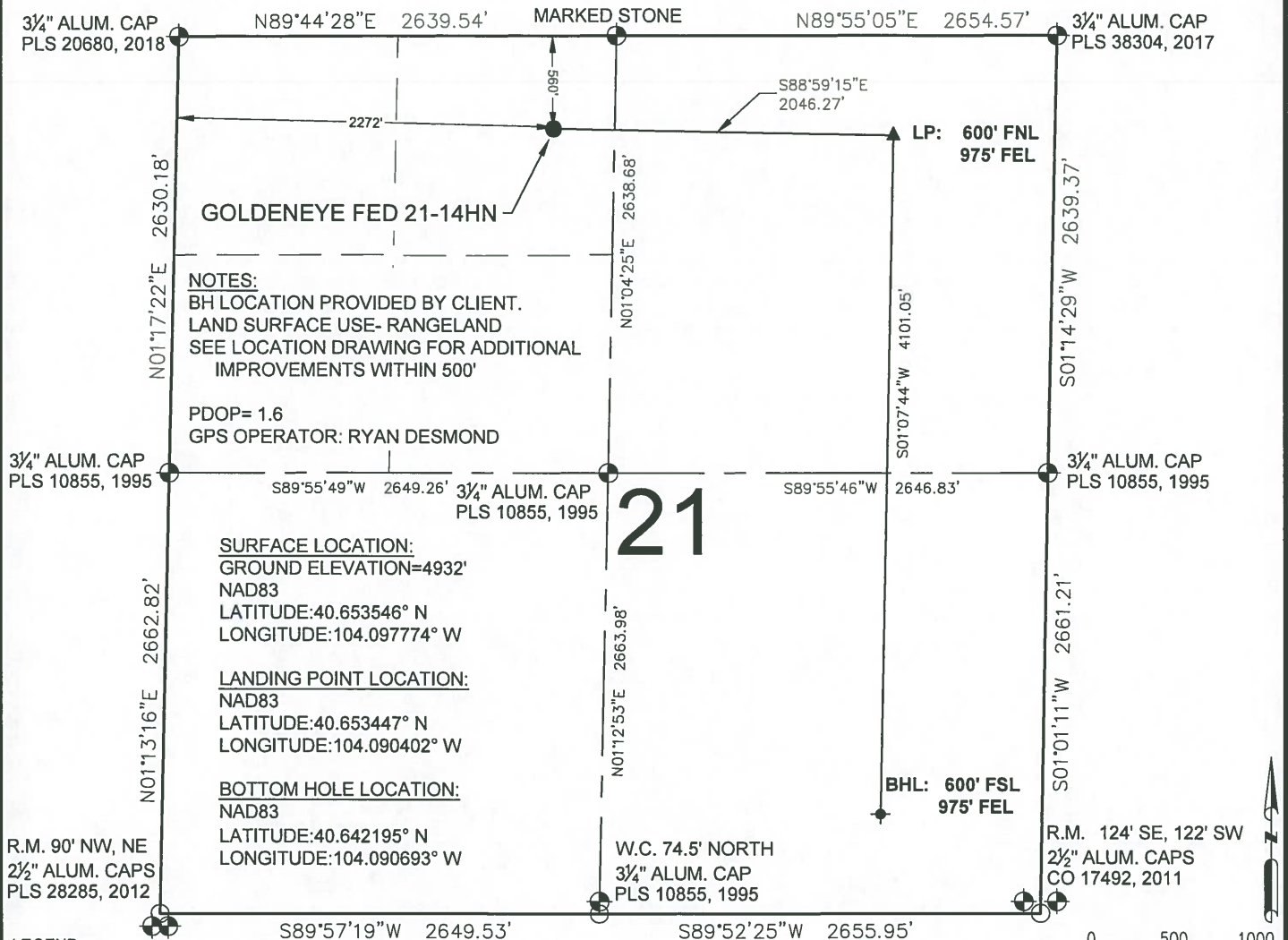


GOLDENEYE FED 21-14HN WELL LOCATION CERTIFICATE
