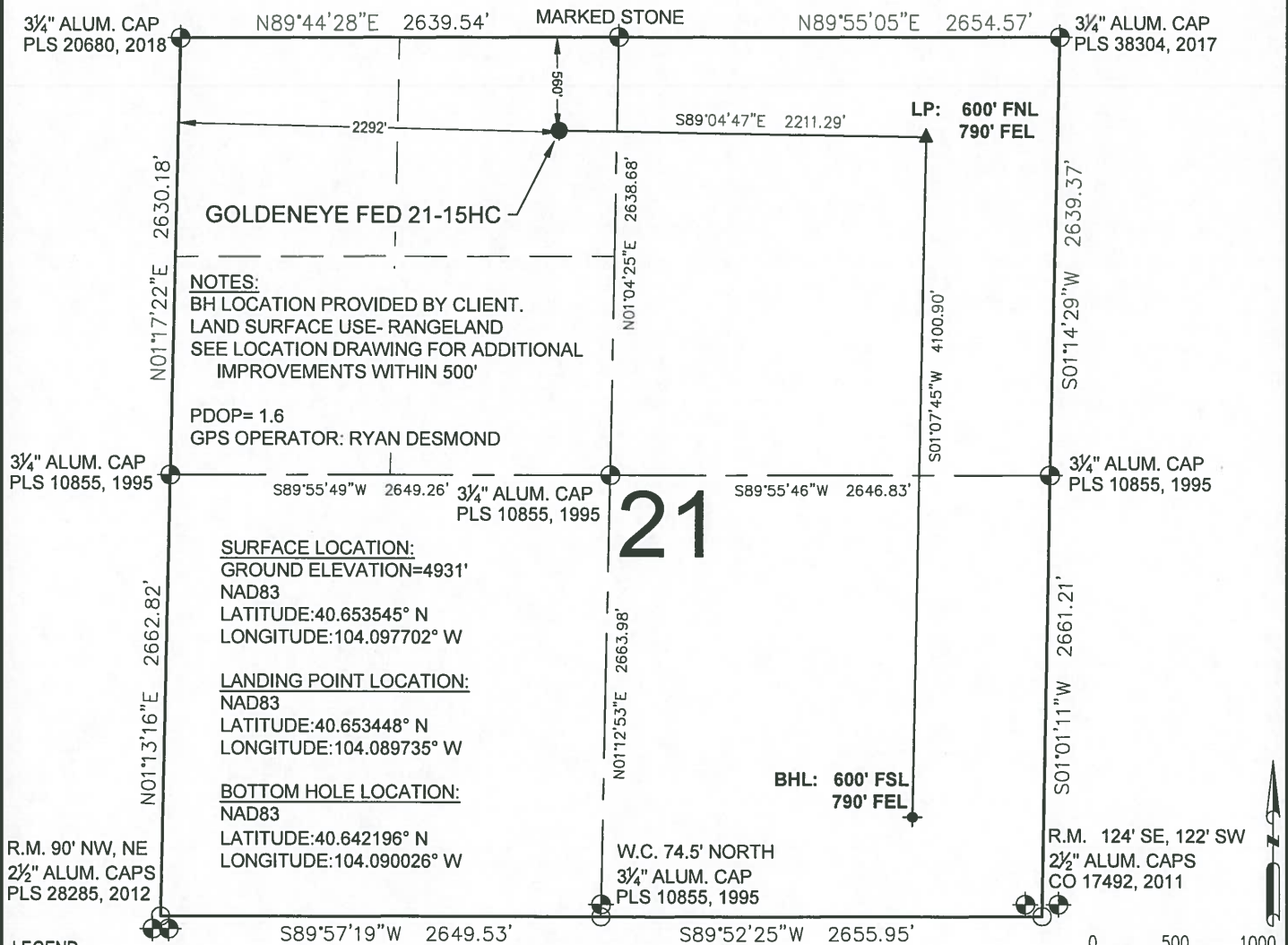


GOLDENEYE FED 21-15HC WELL LOCATION CERTIFICATE
