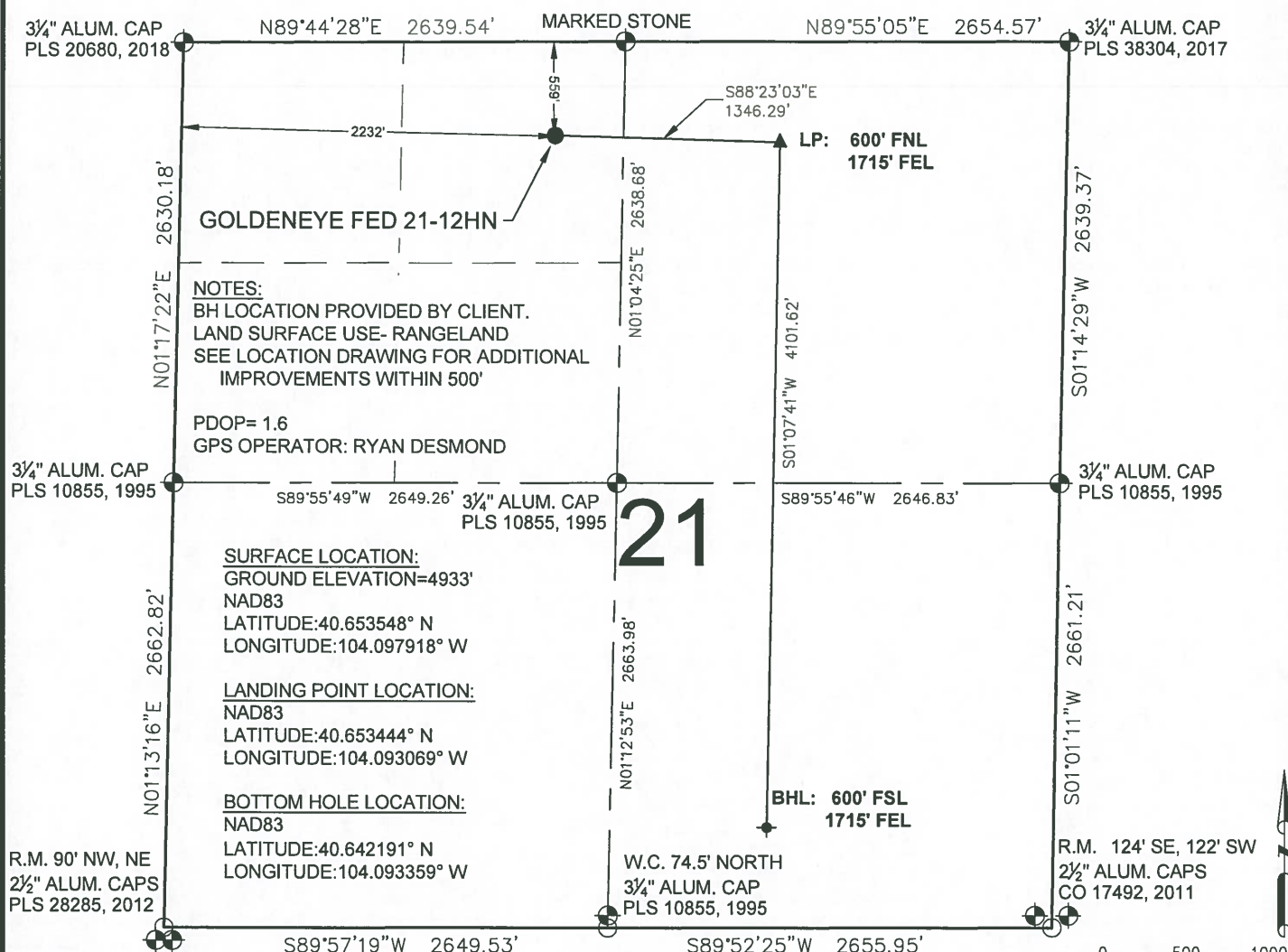


# GOLDENEYE FED 21-12HN WELL LOCATION CERTIFICATE
