period for TA'd wells, a Form 4 Sundry Notice will be filed with the COGCC requesting for an extension to the time period including the reason for the extension request, the method the well is closed to atmosphere, and plans for future operation on or before October 29, 2018.

The April, 2018 Form 7 Production Report (Document #401623911) reported the DC-12 as Shut-In (SI). The well was TA'd on April 30, 2018, so the DC-12 will be reported as TA on the May, 2018 Form 7 Production Report on or before June 15, 2018.
