Operator Comments:

During the drilling of the Well, the well path crossed the western setback of 460' from the unit boundary by approximately 39'. The well path continued outside of the setback for approximately 500'. The well has not yet been completed. Prior to completion, Noble is submitting a Form 4 to amend the Unit Configuration of this well from the spacing of COGCC Order No. 407-1953 to a wellbore spacing unit spaced in accordance with COGCC Rule 318A.a.(4) D. Noble is requesting that the wellbore spacing unit that would make up the Unit Configuration in the Form 4 would be Section 10: E½SE¼, Section 11: W½W½, Section 14: W½W½, Section 23: W½NW¼, NW¼SW¼, Township 2 North, Range 64 West, 6th P.M., Weld County, Colorado ("Wellbore Spacing Unit").

Noble has sent notice per COGCC Rule 318A.e.(5) to all Owners in the wellbore spacing unit. Noble is in receipt of signed waivers from all Owners in the wellbore spacing unit waiving the 30-day notice requirement of said rule. Further, Noble holds 100% operating rights in the lands subject to the 39' encroachment.

Based on the foregoing, Noble respectfully requests that the COGCC review and approve a Form 4 Sundry Notice to amend the Unit Configuration from the Drilling Spacing Unit established in Order 407-1953 to the Wellbore Spacing Unit as follows: Section 10: E½SE¼, Section 11: W½W½, Section 14: W½W½, Section 23: W½NW¼, NW¼SW¼, Township 2 North, Range 64 West, 6th P.M., Weld County, Colorado.
