Comments	<p>The distance to the completed portion of the nearest well on the "Spacing & Formations" tab was measured to the proposed Rinn Valley East N17-20-9N in 2D via COGCC GIS Mapping. The distance to the closest well belonging to another operator on the "Drilling & Waste Plans" tab was measured to Crestone's File 4-2-17 in 3D via the anti-collision report (attached as "other") because when measured in 2D, it appeared that there were no wells belonging to another operator within 1500'.</p> <p>The subject well will have a treated interval less than 150' from the treated interval of the Schlagel 1. Both wells are owned by Extraction Oil & Gas so no stimulation setback consent is needed.</p> <p>The surface owner has waived Rules 318A.a. & 318A.c. in the SUA, highlighted on page 6 of the attached SUA.</p>

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
