The North Platte 44-11-28HZ [API #: 123-33755], operated by Bonanza Creek Energy, is the nearest well in the same formation, the distance was measured in 3D. The well status is currently PR.

The nearest wellbore belonging to another operator was measured to the National Hog Farm 34-21[API #: 123-20366], operated by PDC Energy Inc. The distance was measured in 2D. The well status is currently PR.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached.
