General Comment:

This is a good housekeeping inspection.

This inspection is in response to a surface owner complaint regarding weeds, and weed debris accumulation on CM locations. On 5/24/2018, inspector met with surface owner on location to discuss concerns. Surface owner indicated that weed growth from the previous year, once desicated, became debris and inundated the location. Surface owner stated that she and her husband spent much time cleaning up the debris from the facility.

Surface owner was able to show inspector the major areas of concerns, which appear to be the immediate areas of the battery facility and the two southern pits. Though cheat grass is prevelant throughout the location and the immediate areas, the surface owner specifically pointed out weeds, that were identified as Kochia, as the major cause of her concerns.
