Comment: **This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 1/23/2013. Gravel remains throughout the location and access road and is likely not decompacted. Weedy, annual vegetation was observed which includes but not limited to cheatgrass. Tank Battery has not been removed. Please refer to the attached inspection photos for more detail.**

Corrective Action:	Perform reclamation in accordance to Rule 1004. Since the spring seeding window is close to passing, revegetation activities shall be complete no later than 9/15/17.
