Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Remove the remaining equipment, perform compaction alleviation, re- contour/re-grade access road, and manage noxious weeds.
