## COMMENTS:

The Golding 4 Tank Battery will be upgraded to support an increase in the estimated produced water from the NR 23-3 Pad (Loc ID #422211). The existing tank battery consists of six (6) 500 barrel produced water tanks and four (4) 300 barrel condensate tanks. The existing 300 barrel tanks will be removed and replaced with three (3) 200 barrel condensate tanks. A new tank battery will be installed adjacent to the existing tank battery (north side), and will consist of two (2) 500 barrel produced water tanks and one (1) 400 barrel condensate tank. Total capacity of the tank battery will be 5,000 barrels. The existing emission control device (ECD) will be relocated to the south side of the existing tank battery. A pump will be installed south of the existing tank battery to eliminate the need to haul produced water from the Golding 4 Tank Battery. A new 4-inch produced water pipeline (approx. 990') will be installed from the Golding 4 Tank Pad to an existing 4-inch water pipeline south of the pad. See attached construction and facility layout drawings for details.
