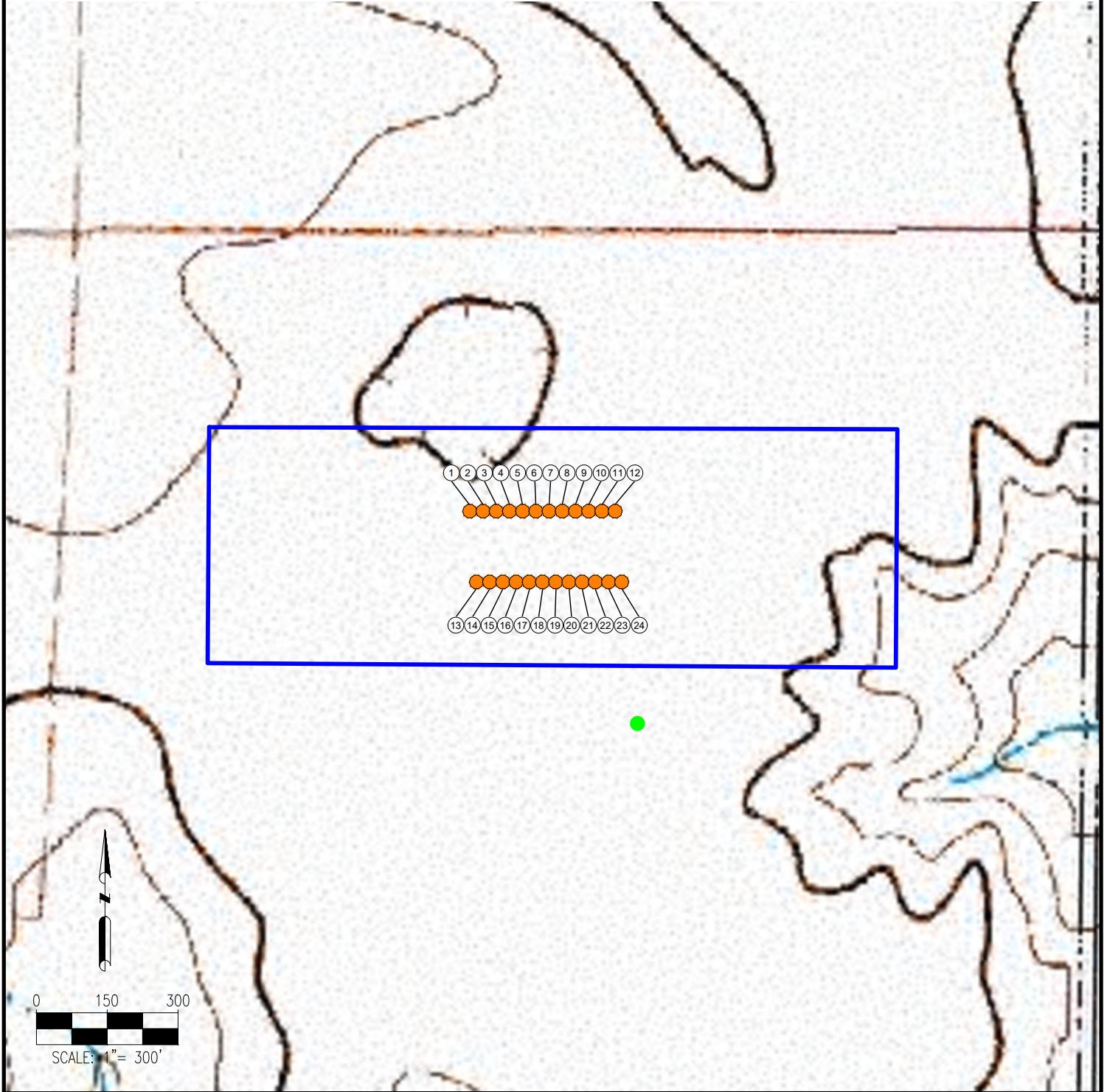


GARDNER (FED) 23-D PAD REFERENCE AREA MAP
