Well was originally shut-in for Horizontal Safety Prep. RBP W/SAND CAP @ 7,003' CIBP W/SAND CAP @ 7,380' A mechanical integrity test was performed to ensure integrity of the casing on 04/29/16. T&A status provided via a down-hole plug and surface isolation provided via closed master valve. The well has been evaluated and is on our schedule to plug and abandon as the cost to unprep exceeds the NPV of the well.
