5	Drilling/Completion Operations	LOGGING EXCEPTION: One of the first wells drilled on the pad will be logged with Cased hole Pulsed Neutron Log with Gamma Ray Log from kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run in that well and have those logs attached. The Form 5 for each well shall clearly state "No open-hole logs were run" and shall reference the Rule 317.p Exception granted for the well.

The AF08-08 Multi Pad (Wells Ranch State AF09-640, 628, 618, 667, 658, and 640) meets the offset log exception requirement to allow a cased hole neutron log to be run on this pad. An offset horizontal well, Wells Ranch AF07-645, API# 05-123-44250, has a resistivity log from surface casing to KOP, DOC# 401635632, and is located ~200 ft. south of the center of this pad.
