Crestone requests that the Lehl 1 (API 123-08027) offset well COA be removed from the 15 proposed wells on the Sam 25H-M166 pad. An offset operator has drilled and frac'd a horizontal well closer to the Lehl 1 than the Sam horizontal wells. Additionally, the TOC is estimated 400' above the Niobrara and the bottom of cement is below the Fox Hills sand which therefore provides isolation of the sand.
