Meeting was regarding both the Ridway and Rifle Falls Location

- Truck traffic – Truck traffic for Ridgway will come from north or south on CR 35, truck traffic for Rifle Falls will come from east on CR 39. Limiting traffic in front of Landowners homes. PDC will mitigate dust as needed.
- Landscaping – Sherman's requested trees. PDC agrees to negotiate individually with Landowners. If trees are provided as screening on Landowner's property, Landowner would have to maintain trees or other landscaping.
- Air Quality – PDC will follow all COGCC and State of Colorado requirements.
- Noise from equipment – PDC will comply with state and county guidelines. Sound walls will be constructed around location during drilling and completion operations and if necessary during production phase.
- Weed Control – PDC will comply with state guidelines.
- Trespassing – PDC will not allow survey companies on Landowners property without permission.

Meeting was regarding both the Ridway and Rifle Falls Location

- Visual Mitigation – PDC agrees to negotiate individually with Landowners. If trees are provided as screening on Landowners property, Landowner would have to maintain trees or other landscaping.
- Sound Mitigation – 32 foot tall sound walls will be constructed for these locations. PDC will comply with state and county guidelines.
- Traffic - Truck traffic for Ridgway will come from north or south on CR 35, truck traffic for Rifle Falls will come from east on CR 39. Limiting traffic in front of Landowners homes. PDC will mitigate dust as needed. PDC anticipates utilizing pipelines to reduce truck traffic.
- Security – PDC has a guard shack on site to provide security for the locations.
- Topsoil – Landowner requested sand burrs be scraped off prior to stock piling topsoil. Landowners will consult with Surface Owners.
- Weed Control – PDC will comply with state guidelines.
- Water testing – PDC will comply with the states water well testing guidelines.
