Utah Gas Op Ltd, dba Utah Gas Corp has conducted final reclamation, re-contouring, and seeding on the Ezra 3 location. This 1.3 acre site was constructed, but not drilled by the previous entity, SWEVCO-SABW, LLC.

Attached is the Final Reclamation Plan, as discussed and agreed upon with the Colorado River Valley field Office of the BLM, during pre-reclamation on-site on Thursday, February 15, 2018. Also attached is a final reclamation site map, showing intended work.

The work was completed between March 19, 2018 and March 30, 2018. Final Reclamation Sundry Notices have been sent to the BLM.
