This location is not in compliance with Rule 1004. The removal of all equipment has not been performed; a riser is still present at the battery location and should have been removed by 11/31/2017. Operator shall complete final reclamation activities at the battery location per Rule 1004 by 8/31/2018, as this was a shared battery location associated with a nearby well (123-22577).

Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct follow-up inspections prior to receiving said notice to ensure compliance with Rule 1004. Please refer to the attached inspection photos for more detail. See COGCC comments.
