Spot and broadcast spraying was conducted for weed management on the facilities, pit and well locations using a dicamba and 2, 4-D amine broadleaf herbicide named Brash, in combination with Succeed surfactant. This herbicide was selected due to its success with managing undesirable weedy broad-leaf plant species in areas within cropland. All areas around the production facilities (well, tank batteries, etc...), and areas around, and within, the pit where undesirable weedy plant species such as Kochia has established were sprayed. Additional monitoring will be conducted by Reclamation Specialist to document results.
