COMMENTS:

PDC requests to add topsoil staging area to this location and increase the size of the temporary MLVT area as shown on the attached Scaled Facility Drawing. The total disturbed acres will be increased to 23, with 3.9 acres of that being for topsoil staging, and 8.6 acres being for temporary MLVTs (a 3.1 acre increase). MLVTs need to be increased because the construction area was not taken into consideration when this location was originally submitted. The reclaimed area will increase slightly to 6.5 acres, where it was previously approved at 6.3. PDC would also like to change the following production equipment: Electric Generator - 1, Blowcase - 1. All other equipment will remain the same. All cultural distances will remain the same as previously approved.

1	Storm Water/Erosion Control	This Stormwater Management Plan contains required elements associated with PDC's construction activities, as defined in the CDPS General Permit for Stormwater Discharges Associated with Construction Activity, Authorization to Discharge Under the Colorado Discharge Permit System (Permit No. COR-030000, re-issued and effective July 1, 2007).BMPs for sediment and erosion control will be accomplished through a combination of construction techniques, vegetation and re-vegetation, administrative controls, and structural features.
2	Construction	The topsoil will be segregated, stockpiled, and protected from degradation due to contamination, compaction, and, to the extent practicable, from wind and water erosion during drilling and production operations so that subsequent reclamation will be facilitated. Topsoils will be compacted and crimped to protect from reeling and will be protected from offsite runoff with a ditch and a berm.
3	Interim Reclamation	In accordance with COGCC Rules, the disturbed area will be monitored for noxious weed infestations during all drilling, production and reclamation operations. These areas will be kept free of all undesirable plant species designated to be noxious weeds, as practicable. Weed control measures shall be conducted in compliance with the Colorado Noxious Weed Act, C.R.S. 35-5.5-115 and the current rules pertaining to the administration and enforcement of the Colorado Noxious Weed Act. Weeds will be mowed and sprayed if necessary.
