Comment:

The City of Firestone requested the gravel from the access road be left in place as there is a well operated K P KAUFFMAN COMPANY INC who uses this road to service their well, Walsh 5 . The Walsh 5 is listed as shut-in on the COGCC website as of 2/1/18 but had active production every month from April 2017 through January 2018.

The electrical on site does not belong to PDC. It was confirmed with United Power that the electric service, meter #1518841, is registered to KP Kaufman.

The weeds in the road itself had all been sprayed and were dead while the weeds in the grass were not. This indicates that someone, other than the Town of Frederick, is making at least some attempt to maintain that road and weeds. Currently, all weeds in the access road have been addressed.
