Comment: COA on Form 4 is as follows:
1.) Submit requests to flare annually to COGCC on Form 4 (Sundry Notice), which discusses timing to connect to sales line, plans to develop infrastructure, and justification for continued venting/flaring. Provide gas analysis, including H2S with each Sundry Notice.
Gas analysis has been scheduled to be completed by the end of June. Upon completion Sundry will be filed. We are in communications with local companies to establish a gas sales contract. These negotiations include building the infrastructure to transport the gas.
2.) Venting or flaring of natural gas shall comply with COGCC Rule 912.
We are compliant with the previous testing and are currently up for renewal.
3.) Report flaring volumes on Form 7, Operators's Monthly Report of Operations.
Gas volumes are included in our monthly production reporting which is being completed each month.
4.) Notify the local emergency dispatch or the local government designee of natural gas flaring.
Local officials have been notified of this flaring.
5.) The operator is required to obtain and maintain any required air permits from CDPHE. The combustion device must comply with the applicable design destruction efficiency for hydrocarbons.
CDPHE air permits and in place and combustion equipment is compliant.
