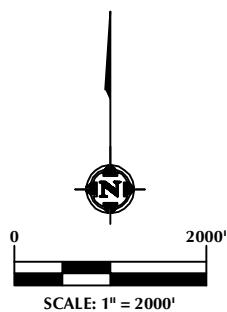

NEAREST UNIT BOUNDARY= 736'

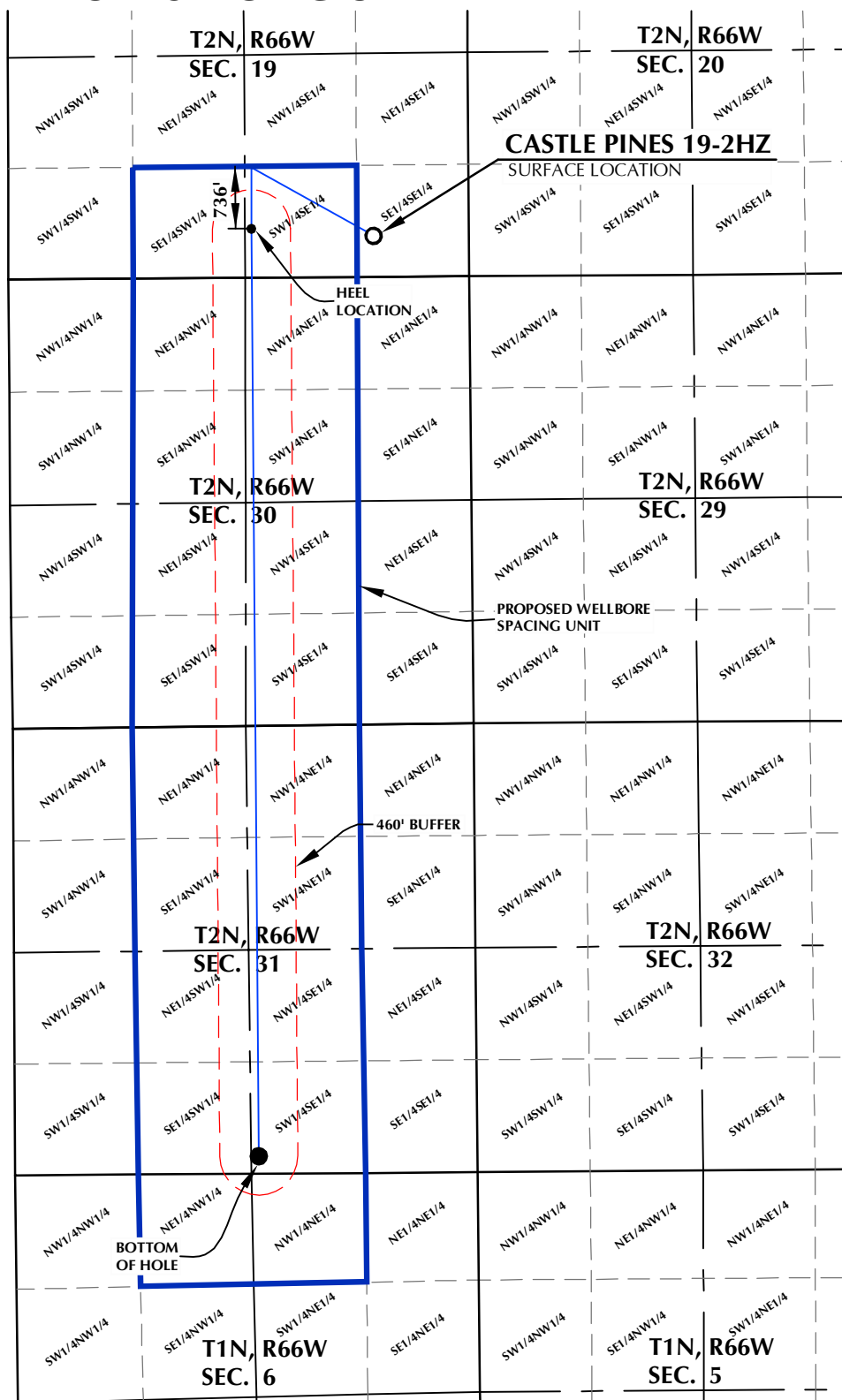
