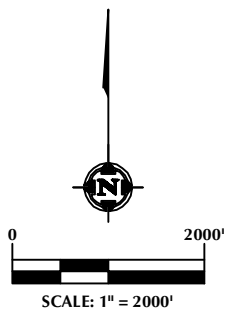

NEAREST UNIT BOUNDARY= 767'

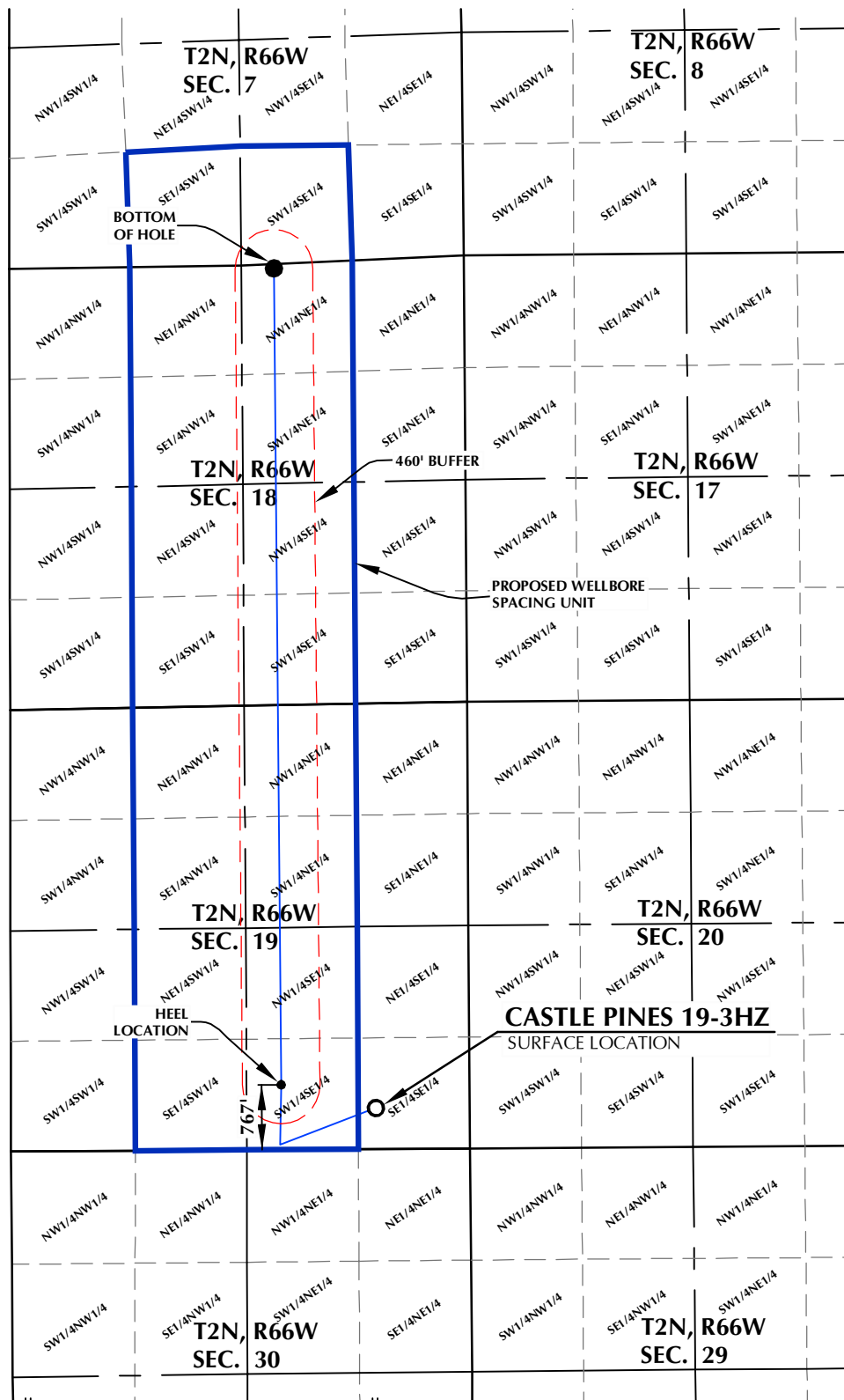
