This well was spudded June 19, 1981, and thereafter abandoned and plugged on December 24, 2003. As of February 23, 2018 the site is and has been used as a dry land corn crop. The location had an area where some of the ground is not growing crop. Remediation was performed in the last few weeks to reclaim the ground, including spreading gypsum and ripping it into the soil.
