3. Run RBP, packer and tubing.
4. Isolate and test each zone.
5. Anticipate acidizing each zone with 500 gals. 15% MCA and 1000 gals. 15% NE acid.
6. TOH with tubing, packer and RBP.
7. Run tubing, pump and rods.
8. Put well back on production with St. Louis, Fort Scott and Marmaton commingled.
