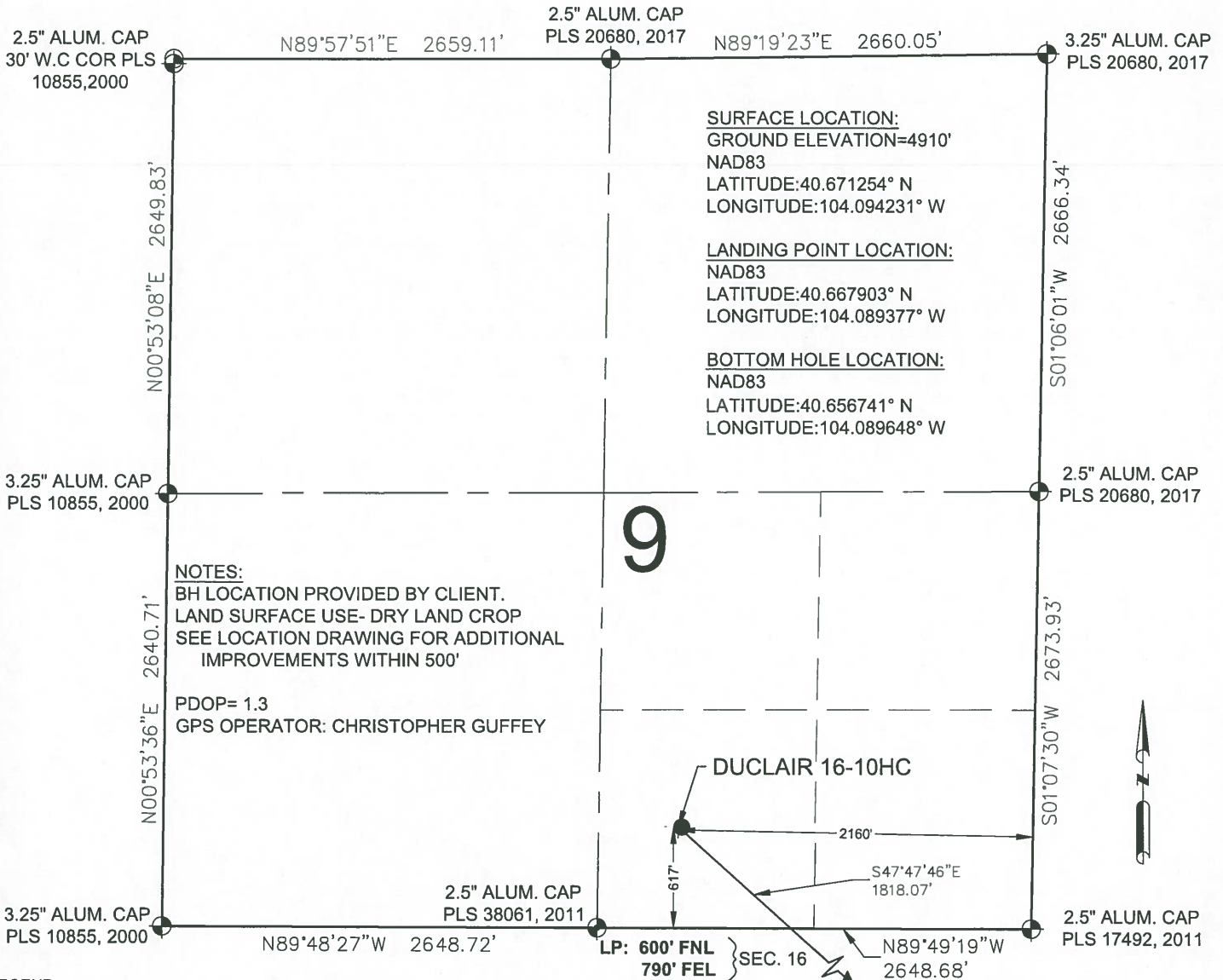


DUCLAIR 16-10HC WELL LOCATION EXHIBIT

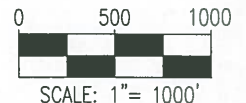

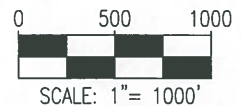
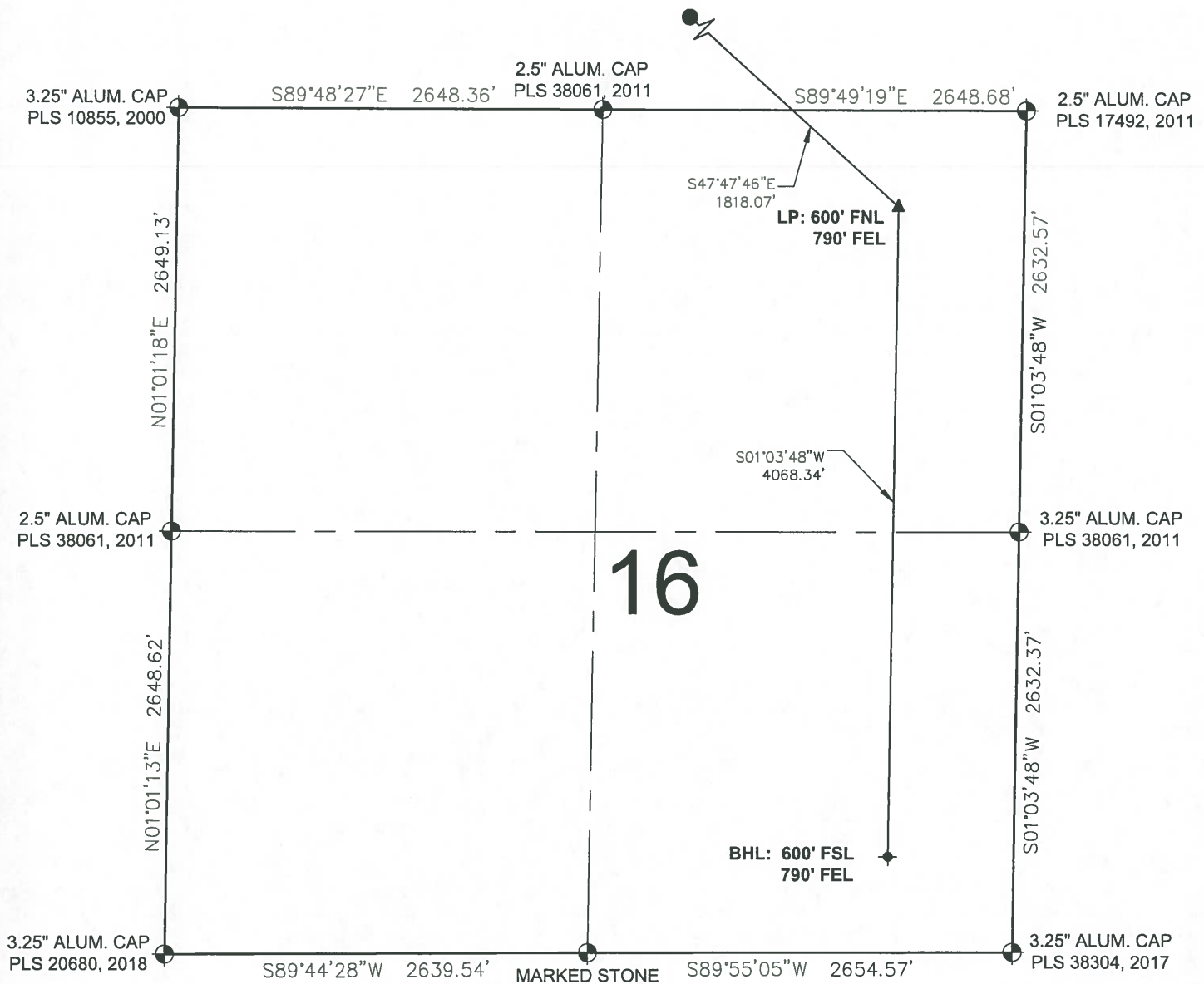
