The BHL footage FWL of Section 15 depicted on the well location plat is less than the required 600' from unit boundary per Spacing Order. Operator will not be completing the well past 600' FWL of Section 15.

Nearest wellbore permitted or completed in the same formation is the Sievers 8-61 15A-8 (Bison Oil & Gas II, LLC), as measured using 3D manual calculations.

All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
