**General Comment:**

Pre-closure Pit #112128 inspection. Three small pits on on location. Pits include: 1) ~500 gallon , open-top, poly tank in 15'x15'x3' excavation with mesh net south of wellhead. 2) 15'x15'x3' netted eathern pit at separator. Dry but staining observed beneath discharge pipe. 3) 15'x15'x3' netted earthen pit north of separator, also dry with stains at discharge pipe.

Close pit in compliance with COGCC rules. Perform closure in accodance with approved F-27 including representative soil samples confirming Table 910-1 compliance. Notify COGCC a minimum of 72 hrs prior to any excavation activity. All reclamation must be performed in compliance with COGCC 1000 rules plus BLM requirements for federal surface lands.
