**General Comment:**

Pre-closure inspection Pits #112108, 112109. Only one pit visible on location. Pit is 15'x15'4". Pit is netted and dry with minimal staining but no odor on surficial soils. 100 bbl crude tank is within earthen SPCC and may have been a former pit.

Close pit in accord with approved F-27, Confirm closure with representative soil samples from sidewalls and bottom of pit in compliance with Table 910-1. Notify COGCC a minimum of 72 hrs prior to excavation and sampling activity. Following COGCC approval, perform reclamation per COGCC 1000 rules and BLM requirements for federal surface lands.
