COMMENTS:

Answers to the questions 5 Questions the COGCC asks for Flare requests are as follows:

- 1) The estimated volume of gas to be flared is expected to be minimal. The well is currently not normally making any gas to sales, Axis would be setting up a meter on the line to the ECD to be sure how much is being burnt and can provide the results to the commission if requested.
- 2) No Hydrogen Sulfide (H₂S) is anticipated, Axis can provide a gas analysis if possible and requested by the Commission.
- 3) APC has just cancelled its contract with Axis and is decommissioning the gathering system in the area, therefore the well will not have midstream. Bringing in another line to a 30 year old vertical well that produces 2-3 BBL/day is not economical, so Axis would be flaring the well until it is plugged and abandoned. Axis would like it noted that they are currently constructing a pipeline to the area for its future developments in the area.
- 4) The operator is intending to flare the associated gas and therefore will comply with the odor provisions of Rule 805.b.(1).
- 5) Axis Exploration intends to use an enclosed flare for encountered gas from the wellhead and ECD's for compliance with storage tank emissions management. All other permitting and compliance provisions for the CDPHE are in process and will be followed as required.
