Work occurred on the Nichols 0994-13-20E well to install production casing patches for 2 collar leaks. A CIBP was installed at 7948' with 2 sacks of cement dump bailed on top. An RBP was installed at 4623'. The first casing patch was installed from 4289.5' - 4311' for a collar leak at 4300'. the second casing patch was installed from 3068.5' - 3089' for a collar leak at 3079'. A wellbore diagram is attached.
